SOMERSET COUNTY TRANSFER STATION PERMIT RENEWAL

On the reverse side you will find the renewal application for your Somerset County Transfer Station Permit. Permits will be \$52.00 per year, and will be in effect from July 1, 2012 to June 30, 2013. **The second additional permit** may be purchased for other vehicles in the household for **\$10.00** each and the **third additional vehicle in the household for \$15.00**. Permits must be attached to the lower left hand corner of the windshield (**OUT-SIDE**) and must be visible to be valid. Proof of residency may be required when in question.

Permit fees for FY 2012/13 will be reduced quarterly and prorated using the following method:

Permits purchased between July 1, 2012 through September 30, 2012 - \$52.00
Permits purchased between October 1, 2012 through December 31, 2012 - \$39.00
Permits purchased between January 1, 2013 through March 31, 2013 - \$26.00
Permits purchased between April 1, 2013 through June 30, 2013 – \$13.00

Only household waste will be accepted at the County Transfer Stations. **NO COMMERCIAL WASTE**. Yard waste, tires, and white goods such as refrigerators, stoves, fuel tanks, etc., will not be accepted at the Transfer Stations. White goods are accepted at the Landfill at no charge. All yard waste such as limbs and bushes will be accepted at the Landfill at no charge providing the load is 500 pounds or less and the vehicle has a valid Transfer Station Permit. Loads suspected of carrying 520 pounds or more of household waste or demolition will not be accepted at the Transfer Station and will be diverted to the Landfill.

Anyone crossing the scales at the Somerset County Landfill with 500 pounds or less of household waste or yard waste will be required to have a permit to be exempt from fees. Permitted vehicles delivering waste amounts of 520 pounds or more will be charged for the entire load at the current tipping fee rate of \$62.00 per ton. Scrap tires will not be accepted at the Transfer Stations and must be taken to the Landfill and disposed of using the following schedule:

Car and Passenger Tires - \$4.00
Large Truck Tires - \$12.00
Tractor and Heavy Equipment Tires - \$.18 per pound

Violation of any of the permit conditions may result in the revocation of the permit by the County.

Applications can be mailed to the address on the front. Permits can also be obtained at the Somerset County Office Complex, Room #203 (8:30 am to 4:30 pm, Monday through Friday).
