

**RESOLUTION 925**

**DOG CONTROL FEES**

WHEREAS, The Somerset County Dog Control Ordinance No. 924 will become effective July 1, 2006; and

WHEREAS, the said Ordinance provides that the fees for enforcement of Dog Control shall be set from time to time by Resolution of this body; and

WHEREAS, Resolution No. 529 requires an amendment to update various Dog Control fees.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS FOR SOMERSET COUNTY, that Resolution No. 529 be repealed and Resolution No. 925 be enacted, and effective the 1st day of July, 2006, to implement the following Dog Control enforcement fees:

**ORDINANCE NO. 924**

**Article II**

**Section 7. Mother Dog and Puppies**

- a. When puppies are turned in without the mother dog, there will be a charge of \$5.00 per puppy.
- b. If the owner wants to keep the mother dog, a fee of \$25.00 will be charged at the time the puppies are relinquished.
- c. If owner wishes to avoid the fee, the owner will have thirty (30) days to have said mother dog spayed, and then upon verification that the mother dog has been spayed, owner will be refunded full amount of the \$25.00 fee.

1 <sup>st</sup> Offense Redemption Fee	<u>\$25.00</u>
2 <sup>nd</sup> Offense Redemption Fee	<u>\$50.00</u>
Maintenance Fee	<u>\$ 3.00 per day for dog held at pound</u>

**Section 11 Adoption of Unredeemed Dogs**

Dogs under four months of age	<u>\$5.00</u>
Dogs over four months of age	<u>\$5.00 plus \$12.50 for rabies vaccination</u>

**Section 14 Potentially Dangerous/dangerous dogs, not to run at large; impounded; redemption**

Redemption fee \$ 500.00

**Section 22 Disposition of Dead Dogs**


The Dog Control Warden shall, upon request, pick up dead dogs for disposal for a fee not to exceed \$25.00.


